- Stratification there are two stratification options available for promotion eligible MSgts and SMSgts. Higher Level Reviewers can stratify up to 25% of promotion eligible members. When determining the quota, normal rounding rules apply (.49 rounds down to the whole number and .50 rounds up to the whole number)
 - SMSgts Top 20% of SMSgts will receive a numerator and denominator stratification, e.g., #1 of 7 SMSgts, #4 of 24 SMSgts. An additional 5% of SMSgts will receive a stratification statement of "Top 25% of SMSgts"
 - MSgts Top 10% of MSgts will receive a numerator/denominator stratification, e.g., #1 of 11 MSgts, #2 of 24 MSgts. An additional 15% of MSgts will receive a stratification statement of "Top 25% of MSgts"
