SUBJECT: FY17 Seasoning Training Program (STP) Guidance

1. STP has proven to an essential tool in developing our Airmen and maintaining our high mission readiness levels. In accordance with current program guidance, the approved FY17 Command Critical Skills AFSC List (CSL) (attached) will be incorporated within the FY17 STP with the following exception:

a. AFRC/CC approved the addition of the 2G0X1 (Logistic Plans), 5J0X1 (Paralegal) and 4H0X1 (Cardiopulmonary Laboratory) AFSCs to the FY 17 STP.

2. Within the STP, STP 1 includes skills approved on the CSL (with exceptions) while STP 2 includes all other skills. The tours within STP 1 are limited up to a maximum of 139 days (as determined by the HQ AFRC Functional Manager). Any training in excess of 139 days will require use of distributed STP 2 funding or wing discretionary funding. STP 2 tours are locally managed.

3. The intent of STP is to build a ready force through specific core task training. Appropriate monitoring and documentation of training progression is required. Orders will be curtailed in instances where members complete core tasks in advance of their STP tour end date.

FY17 COMMAND CRITICAL SKILLS AFSC LIST (Effective 1 October 2016 to 30 September 2017)

Definition: Critical Skills are selected based on mission needs of AFRC and the designation of a critical skill may be assigned to any Duty Air Force Specialty Code (DAFSC). These skills must have a historical, current or projected shortage of personnel in addition to being deemed a mission critical skill MAJCOM- wide. **NOTE: Asterisk (*) reflects the AFRC/CC approved AFSC additions to FY17 Critical Skills List and double asterisk (**) for the <u>FY17 Seasoning Training</u> <u>Program (STP) 1</u> by exception.**
