From the Commander:

Orders Process:

We're all experiencing impacts of the fiscally constrained environment we currently are operating in, unfortunately it would appear this has become more norm than exception. Our goal at HQ RIO Detachment 6 is to provide you with published orders at least five calendar days prior to the start date of your duty. The orders process can be bureaucratic and complex due to the many legal/monetary requirements and different organizational touch points along the way before an order is officially approved.

Det 6 is just one stop in that process. Timely submission of orders requests is not only required by AFI, it secures necessary funding that enables all our IR's to meet participation requirements. As such, I expect IRs to submit orders requests *30 calendar days* ahead of their requested start date to meet the necessary timeline IAW AFI 36-2254V1, para 6.5.4.

The Det 6 Readiness staff will provide you with a Verbal Order of the Commander (VOCO) if this five-day threshold cannot be met as a result of systems issues or delays within HQ RIO. That allows you to make travel arrangements a few days ahead of time to hopefully avoid any last minute problems that may occur. However, VOCOs do not allocate funding and therefore are not payable orders.

Due to the large influx of last-minute orders not driven by bona fide mission needs, anyone entering an order request in AROWS that is less than two weeks from the start date of duty must also submit a VOCO request for my approval. This VOCO must provide *detailed* mission justification for the short notice request and be signed by your active duty commander. IRs without certified orders or a signed VOCO from Det 6 are *not* in any duty status, and therefore are *not* authorized to report to duty.

Last-minute orders requests without strong justification for the late submission will be disapproved. These sudden "emergencies" too often end up delaying processing of other requests that were submitted in a timely manner, causing them to become "emergencies" as well. This vicious cycle has become unsustainable, and we need to return to a normalized first-in/first-out battle rhythm.

We fully understand there are exceptions (such as with the Emergency Preparedness Liaison Officers), and some late submissions are inevitable. However, those are the exception and not the norm. If mission needs drive you to submit a last-minute request, I'm asking that you call or email our Det 6 Readiness & Integration staff at 813-828-5035, option 2 (DSN 968) as soon as you are aware of the requirement. Early communication is essential! Help us help you stay committed to supporting your training requirements and the active duty mission. We owe it to each other to do our respective parts.

Post 9/11 Transfer Education Benefits Policy Change:

Recently the Office of the Under Secretary of Defense has issued an extension to the July 12, 2019 deadline to Department of Defense Instruction (DoDI) 1341.13, Post-9/11 GI Bill, updating policy on the Transfer of Education Benefits (TEB) by Service members to eligible dependents. The Department extended the implementation period from 12 to 18 months. **Members will have now until January 12, 2020 to transfer their Education Benefits.** Eligibility to transfer benefits will now only be limited to service members with at least 6 years, but not more than 16 years of total creditable service. The determination of service members' total years of creditable service will be based on the date of the member's TEB application, not the date the request is approved. CCAF sets end date for Professional Manager Certification:

The Community College of the Air Force will no longer accept applications for the Professional Manager Certification program after Sept. 30, 2019. The program termination comes after the Air Force COOL Program having 31 civilian industry leadership and management professional certifications available to senior noncommissioned officers.

To be eligible for the PMC, Airmen must have been awarded a CCAF degree and the 7 skill-level or higher. They must have also completed Airman Leadership School, Noncommissioned Officer Academy, Senior Noncommissioned Officer Academy, or their equivalent, and also completed 30 semester hours of leadership/management coursework.

IDT Submission in UTAPS for Fiscal Year 2020:

AFRC is requiring IDTs be scheduled in UTAPS by **15 August 2019** in order to allocate the FY2020 funding. It's also a mechanism for AFRC to forecast end strength. As proactive IMAs you should already be planning your FY20 duty plan . You can always change the IDTs dates later, but please meet this suspense.

In the meantime, maintain your readiness (Green to GO!), make yourself value-added to your active duty organization, and continue to represent the U.S. Air Force in a manner to be respected.
