

Getting Ready for a Voluntary Tour - Det 6 has created a Voluntary Tour checklist to assist you in preparing for active duty tours. The checklist walks you through the requirements needed to perform a tour like providing a Readiness Report and proof of fiscal year participation. It provides links to the appropriate systems as well as a timeline so that you and your AC unit can plan for an achievable/legal report date. Reporting for duty with the appropriate documentation and preparedness is what the Air Force must do to take care of our Citizen Airmen. Please make this mission a success and ensure you initiate your order with all required authorizations, like M4S, in AROWs NLT 15 days prior to report date. Legitimate emergencies/short notice requirements, like our Emergency Preparedness Liaison Officers (EPLOs) responding to the floods in Texas, will of course be processed within this timeline and may require a VOCO, but these will be by exception only. The checklist is posted on our Det 6 public website or request a copy from our det org box (riodet6@us.af.mil).

HOT - UTAPSweb System Access Changes—UTAPS has implemented a 30/90 day account security requirements. The change will include 8 challenge questions. Upon entering the UTAPS landing page, you will be required to set up 3 of the 8 questions. After 30 days of inactivity, your account will automatically be placed into a disabled function. You will be able to reactivate your account once you answer your security questions correctly, as long as it has not been over 90 days of inactivity. After 90 days of inactivity, your account will be deactivated and you will be required to contact the HQ AFRC Technical Support Desk.

DTS—On June 15, 2015, the Department of Defense (DoD) will launch an Integrated Lodging Program Pilot that will provide quality government (DoD) and commercial lodging, with greater safety and security and better services at reduced rates. Travelers TDY (for 30 days or less) to select DoD locations will be directed to book lodging in the Defense Travel System (DTS) and use government or preferred commercial lodging before other lodging accommodations.

AROWS System Updates—Tour of Duty Certification (TODC) supervisors can now view and/or print their IMAs orders.
