Clothing Replacement Process

IRs who have no prior AF affiliation are entitled to an initial issue. IMAs with prior AF service with a 90-day or greater break are entitled to a replacement-in-kind issue. Current members are entitled to a replacement-in-kind every 3 years of duty. What you will need: AF FM 656, DOD ID #, e-mail and mailing address, phone # and sizes of items requested. Your items will then be mailed to you. Note: It is imperative that you know your uniform sizes. We recommend you request items at least 30 days in advance. Some items maybe on back order and can take longer than usual to receive so please plan accordingly. For emergency items, contact rioret6@us.af.mil.

In general, officers are not eligible for uniform replacements. EXCEPTION: An initial uniform allowance is given at the beginning of their assignment to the AF Reserve and they are eligible once every 2 years for an additional allowance if they have served on AD for 91 or more consecutive days. To obtain the additional allowance, submit an AF IMT 1969, Officer Uniform Allowance Certificate, directly to servicing RPO. NOTE: PIRR members are responsible for purchasing their own uniform items. No reimbursement is authorized.

Suicide Prevention and Awareness Training

Suicide prevention is the responsibility of the entire Air Force community. This annual training is now required to be completed face to face vs online. IRs will need to coordinate with there AD Units to complete this training.

AT Orders Submission (HOT!!!!)

IMAs must submit AT orders in AROWS NLT 1 June 2015. Planning and coordinating your schedule will not only assist in ensuring that you are meeting your FY and R/R requirements but will also ensure that appropriate and adequate training is prepared/provided. If you do not request your AT by 1 June 2015, your tour may not be funded, which will cause you to have a bad year and possibly be subject to involuntary reassignment to the IRR or discharge for unsatisfactory participation.
