At 36 months 100% Post 911 GI BILL = BAH at E-5 Rate Based on the Zip code of the school, payment of tuition to the school at the rate of \$22,805 year for the state of Colorado, and \$1000 dollar book stipend.

At 100% you can also apply for the yellow ribbon program if your school has it. The yellow ribbon will pay left over tuition that you owe to the school. However you have to check the schools yellow ribbon program policy.
