SUBJECT: CY19 Air Force Reserve Developmental Education (DE) Board Key Milestones and Dates

- 1. Headquarters Air Reserve Personnel Center (HQ ARPC) will convene *four* competitive DE boards during calendar year (CY) 2019 IAW the CY19 AFR Force Development Board Schedule released in ARPCM 18-23.
- 2. Each attachment outlines key dates and milestones for each convening selection board. Units are highly encouraged to define internal key dates/suspenses in order to ensure the maximum participation from AFR members in applying for and meeting these boards.
- 3. It is a reasonable expectation that all boards will convene and adjourn per the schedule, and results publicly released within 4-6 weeks after the board convenes. Tentative dates for the board out-brief, close-hold, and public release dates are indicated; however, these dates are likely to change. Notifications will be disseminated to the field when dates are confirmed.
- 4. All members, raters, and military personnel functional organizations should be familiar with the eligibility criteria and process for submitting applications for DE courses. Details can be found in the *Invitation to Apply* associated with each convening board, which is released to the field upon initiation of each application cycle. For questions relating to the AFR School Selection Board process, please consult the *Invitation to Apply* instructions associated with each board.
