SUBJECT: February Update on Digital Transformation

Headquarters AF/A1 continues to make progress with transitioning all personnel systems currently located on the myPers website onto the myFSS and MyVector platforms. As mentioned previously, the deadline for transferring systems to the new platforms is 30 April 2023 when the myPers system shuts down. While the team here at ARPC works diligently to prepare for the deadline, my intention is to inform all Airmen served by ARPC about what functions have transferred over to a new platform and what functions are transferring next.

Throughout the transition, Airmen can expect to see announcements and instructions from ARPC. Additionally, the attached graphic shows which systems have gone live, and the timeline for future systems currently in development. For instance, on the myFSS platform, Service Verification/DD214 Requests and Points Corrections Requests are now live. The next functions scheduled to transition to the myFSS platform throughout March include Reserve Service Program and IRR PIM Readiness.

On the MyVector platform, updates are in progress to better enhance the user experience and provide Airmen with more options for career management. Systems currently available on MyVector include AGR Advertising and Hiring, AGR Management Requests, AFR Developmental Education and AFR Developmental Teams. The updates coming in March include AFR Reserve Assignments and AFR Duty History Update Request.

For more specific information about the transition, please visit your FSS or CSS. Individual Reservists, please reach out to your detachment with questions. The team here at ARPC is working hard to ensure the system migration is thorough and timely. As part of the process, we are here with you every step of the way and will continue to provide service and guidance for all Airmen as we navigate this transition.
