Topic: Military Records Retrieval Transition

Impact: Retired and Separated Air Force members

BLUF: The Military Records Retrieval function is now available on myFSS. Incidents already submitted within myPers will continue to be processed in myPers.

Effective immediately, Retired and Separated Air Force members should utilize myFSS to submit Military Records Retrieval requests. Incidents submitted through myPers will no longer be accepted and will need to be submitted through myFSS. Previous incidents within myPers will be processed. Please do not submit a duplicate request though myFSS.

To submit a new request in myFSS, navigate to the <u>myFSS landing page</u> and enter the title of the Knowledge Article into the Knowledge Article search bar located at the top of the page:

AFR/ANG Military Records Retrieval

Review the Knowledge Article and select the "Create a Request" button at the bottom of the page to initiate a request.

Impact: Air National Guard and Air Force Reserve Airmen

BLUF: The Defense Enrollment Eligibility Reporting System (DEERS) and Real-Time Automated Personnel Identification System (RAPIDS) Project Office function is now available on myFSS.

Effective immediately, Air National Guard and Air Force Reserve members should utilize myFSS to submit DEERS/RAPIDS Project Office requests. Incidents already submitted within myPers will continue to be processed in myPers, please do not submit a duplicate request through myFSS.

To submit a new request in myFSS, navigate to the <u>myFSS landing page</u> and enter the title of the Knowledge Article into the Knowledge Article search bar located at the top of the page:

Topic: myRetirement

Applicable to: Air National Guard and Air Force Reserve Airmen

BLUF: Retirement applications, Reserve Component Survivor Benefit Plan (RCSBP) and 20 Year Letter requests are now available on myFSS.

Effective immediately, members should submit retirement applications on myFSS. We appreciate your patience during the transition period as we are processing applications from both systems as fast as we can.

Retirement applications and RRPA that were submitted to ARPC and have a myPers incident number are in the process of moving over to myFSS and will be worked as quickly as possible. Please do not submit a duplicate request through myFSS.

New RRPA applications should be submitted on myFSS. Anyone who previously submitted an RRPA application in vPC should wait until the transfer is complete on/about 1 May before submitting an inquiry on the status of their application. We will send out an update to notify Airmen when the transfer of their application is complete.
