Job Description: **DUTY TITLE: IMA Medical Inspector DUTIES AND RESPONSIBILITIES:** Responsible for conducting Secretary of the Air Force-directed Unit Effectiveness Inspections of Active Duty, Air Force Reserve, Air National Guard, and Aeromedical Evacuation units worldwide to advance continuous improvement across the Air Force Medical Service enterprise, a 5.9 billion, 44,000-person, integrated health care delivery system serving 2.6 million beneficiaries. Validates mission readiness for 487,000 Total Force Airmen. Identifies undetected non-compliance predominantly in the areas of the aerospace medicine enterprise, duty limiting conditions, and deployment health, however, cross-functional validation of programs such as Patient Safety, Medical Credentialing, Suicide Prevention Program, Sexual Assault Medical Response to the Victim, Occupational and Environmental Health, Public Health Emergencies and Incidents of Public Health Concern, and Arming Use of Force is also possible. Establishes risk-based sampling strategies in accordance with the tenets of Air Force Instruction 90-201 to optimize validation and verification of approximately 33 cross-functional programs. Integrates with Major Command Inspector General teams to serve as core medical inspector. Maintains situational awareness specific to each MAJCOM IG's standard operating procedures while conducting UEIs.
