



This is a Joint Duty Assignment List (JDAL) position and managed within the Key, Command and Joint assignments process. In an attempt to grow the next generation of AFR leaders, only the most qualified officers will be compete. KCJ positions are intended for those who have been identified as High Potential Officers (HPO) by their Career Field Development Teams (DTs) and/or on the Reserve Command screening Board (RCSB) list. Placement into a KCJ position shall be limited to a term of 3 years. The incumbent will receive Joint credit if they work at least 36 duty days per year at the joint organization (IDT's only count for .5 day) and remain assigned for at least 2 years. Additional experience points are required to obtain Joint Qualified Officer eligibility.

Note: ARPC/DPAF manages Key and Joint positions within the (KCJ) assignment's program for the AF Reserve Command.

2. **DUTIES & RESPONSIBILITIES:** Selectee will be assigned to the 954th Reserve Support Squadron within the Joint Transportation Reserve Unit (JTRU) to support the US Transportation Command (USTC) J2 Intelligence Directorate. JTRU Joint Intelligence Officers augment their Active Component counterparts in planning, organizing, and leading 24/7/365 indications and warning efforts, as well as delivering timely, relevant, actionable current intelligence support to the Commander, USTRANSCOM, the Director of Intelligence, and the multiservice component commands. This position provides critical intelligence support to current USTRANSCOM operations as directed by CJCS and enables transportation planners with actionable, all-source threat identification and analysis, transportation infrastructure intelligence, perspective, and force protection information regarding the worldwide Defense Transportation System. Additionally, the SWO orchestrates production of 4-star intelligence update briefs and coordinates intelligence operations across the Intelligence Directorate.
3. **QUALIFICATIONS:** Candidates must be an O-4 or O-5 in the 14N AFSC, and have completed PME commensurate with rank. Preference given to HPOs identified on the Intelligence Key Position List.
